Sanction is hereby accorded to the :-

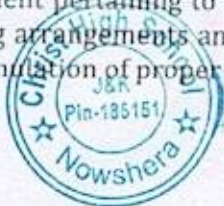

- Grant of recognition in favour of one (01) newly established Higher Secondary institute of Jammu Division for the period as mentioned in the annexure "C" to this order.



The above sanction shall be further subject to the fulfillment of the following conditions:-

- The recognition is co-terminus with the period of affiliation granted by J&K BOSE/Affiliation Committee.
- Compliance to the condition prescribed in the NOCs issued by the competent authorities and in particular, the School Education Department pertaining to safe transportation of children, boarding/de-boarding arrangements and deployment of ~~personnel~~ <sup>Manager</sup> for the purpose & also formulation of proper traffic management plan.






